Department of Disabilities, Aging, and Independent Living Rate <u>Increases</u>

Policy Summary:

The Vermont Medicaid program proposes to increase funding for services delivered under the Department of Disabilities, Aging, and Independent Living. This change is the result of the State Fiscal Year 2025 Appropriations Act. This proposal includes a 3% increase in funding for the affected programs as of July 01, 2024. The funding increase applying to the Disabilities Services Program impacts the bundled service rate in addition to fee-for-service. The value-based payment approach as described in <u>GCR 23-046</u> remains unchanged.

The affected programs are:

- Brain Injury
- Choices for Care
- Developmental Disabilities Services
- State Plan Adult Day Health Rehabilitation Services

Effective Date: July 1, 2024

Authority/Legal Basis: Medicaid State Plan

This change is being done through Global Commitment to Health waiver authority, where DVHA may establish rates with providers on an individual or class basis without regard to the rates currently set forth in the approved State Plan.

<u>Global Commitment to Health Waiver</u>: Waiver authority #5 [Section 1902(a)(13), 1902(a)(30)]; Special Term and Condition #6.8.
