## **High Technology Nursing Program Payment Model**

### **Policy Summary:**

Vermont Medicaid is proposing three additional value-based payment measures for the High Technology Nursing Program delivered by home health agencies.

The proposed value-based performance measures include:

1. Percentage of authorized hours provided by the home health agency across all beneficiaries for the entire year. The target is an increase in authorized hours provided with a minimum threshold for payment of 60% of authorized hours delivered across all beneficiaries for the year.
2. Percent improvement in authorized hours provided. The target is an increase from prior year to performance year with a minimum threshold of 10% improvement from prior year to performance year.
3. New referral acceptance. The target is 100% of referrals accepted.

The High Technology Nursing program is an intensive home care program for eligible Medicaid beneficiaries who are dependent upon medical technology or whose condition requires regular individual and continuous care by a registered nurse or licensed practical nurse.

The existing model includes a measure focused on percentage of authorized hours provided to each recipient each month; an increase in authorized hours provided per month is the target. Currently a higher FFS rate is paid when the home health agency delivers at least 50% or more of authorized hours to the recipient.

This value-based payment is supported by the Home and Community Based Services (HCBS) enhanced funding for certain Medicaid expenditures that was offered to states under Section 9817 of the American Rescue Plan Act of 2021.
