# Reimbursement for Federally Qualified Health Centers and Rural Health Clinics

# **Policy Summary:**

The Vermont Medicaid program proposes to increase the Federally Qualified Health Center (FQHC) and Rural Health Clinic (RHC) Prospective Payment System (PPS) rates by 10 percent for dates of service on or after July 1, 2023. This increased funding is part of the State Fiscal Year 2024 budget appropriation from the Vermont State Legislature.

### **Effective Date:**

July 1, 2023

# **Authority/Legal Basis:**

Medicaid State Plan

State Fiscal Year 2024 Appropriations Act (H.494 of 2023)

This change is being done through Global Commitment to Health waiver authority, where DVHA may establish rates with providers on an individual or class basis without regard to the rates currently set forth in the approved State Plan.

Global Commitment to Health Waiver: Waiver authority #5 [Section 1902(a)(13), 1902(a)(30)]; Special Term and Condition #6.8.

# **Fiscal Impact:**

The estimated gross annualized budget impact is \$4,270,000.
