## Health Benefits Eligibility and Enrollment Rules Update

### **Policy Summary:**

The Agency of Human Services (AHS) has filed the following adopted rules with the Office of the Secretary of State (SOS) and the Legislative Committee on Administrative Rules (LCAR), referenced as Health Benefits Eligibility and Enrollment (HBEE) rules: Updates are made regularly including to implement changes in federal and state law and guidance.

- GCR 22-029: HBEE Part 1 General Provisions and Definitions
- GCR 22-030: HBEE Part 2 Eligibility Standards
- GCR 22-031: HBEE Part 3 Nonfinancial Eligibility Requirements
- GCR 22-032: HBEE Part 5 Financial Methodologies
- GCR 22-033: HBEE Part 7 Eligibility-and-Enrollment Procedures

The rules are effective as of January 1, 2023 and will supersede HBEE Parts 1, 5, and 7 that went into effect on October 1, 2021, and Parts 2 and 3 that went into effect on January 15, 2019.

The HBEE establishes eligibility and enrollment requirements for Medicaid/Dr. Dynasaur as well as qualified health plan (QHP) insurance coverage. The adopted rules align HBEE, Parts 1, 2, 3, 5, and 7, with federal and state law and guidance, provide clarification, correct information, improve clarity, and make technical corrections. Substantive revisions include:

- codifying the annual open enrollment period for Qualified Health Plans from November 1 – January 15;
- adding a new income-based special enrollment period for Qualified Health Plans that allows ongoing enrollment for those at or below 200% of the Federal Poverty Level (FPL) (see also <u>GCR 22-026</u>);
- extending the Medicaid postpartum period for pregnant women from 60 days to 12 months;
- adding Compacts of Free Association (COFA) migrants as qualified non-citizens eligible for Medicaid and exempt from the 5-year bar;
- adding a reference to a standardized eligibility tool for Katie Beckett Medicaid;



- expanding Medicaid eligibility for former foster care children to include children aging out of foster care in another state; and
- In response to comment, the rule also addresses the Affordable Care Act's "family glitch" regarding affordability of employer coverage.

January 1, 2023

#### Authority/Legal Basis:

#### **Population Affected:**

Medicaid and Qualified Health Plan applicants and enrollees.

#### **Fiscal Impact:**

The estimated gross annualized budget impact is \$2,052,700 attributable to the Medicaid program expansions included in the adopted rule.

#### **Public Comment Period:**

The public comment period on these rules closed on August 24, 2022. Comments were received on HBEE Part 2 and Part 3 during the public comment period. A general comment was also received on a topic outside the scope of the HBEE rule. No comments were received for HBEE Part 1, 5, and 7. <u>Comments received</u>, and the <u>responsiveness summary</u> are available here.

HBEE Part 2 and Part 3 were amended in response to comments received from Vermont Legal Aid, Inc. (VLA). The <u>summary of technical changes</u> is available here.

One change was made in HBEE Part 2 from the final proposed rule:

• HBEE 8.05(k)(6)(i)(A) was revised to change the words "this part" to "8.05(k)(6)."
