## **Mental Health Case Rate Update**

### **Policy Summary:**

The Vermont Medicaid program is increasing the monthly case rates for Department of Mental Health (DMH) funded programs. Monthly bundled case rates for services delivered by Designated Agencies and Specialized Services Agencies will receive an 8% funding increase. This includes Mental Health Clinic payment reform, Integrating Family Services (when delivered by a Designated Agency), and Pathways Vermont monthly bundled case rates. A rate table can be found under “Additional Information” below. Please note that the Integrating Family Services monthly bundled case rate for the Addison County Parent Child Center is addressed in [GCR 22-064](#).

A portion of this funding increase will be used to increase the value-based purchasing component of the Designated Agency payment reform to 2%.

This increased funding is part of the State Fiscal Year 2023 budget appropriation from the Vermont State Legislature.
