RE: GCR 22-125, Medicaid Investment: Medically Necessary Abortions

The Vermont Medical Society, Vermont Academy of Family Physicians, American Academy of Pediatrics Vermont Chapter and Vermont Psychiatric Association submit these joint comments in response to GCR 22-135, Medicaid Investment: Medically Necessary Abortions. We write to support the proposed use of the State's authority under the Global Commitment to Health Section 1115 Demonstration waiver to fund abortion services without regard to residency requirements or income.

Our organizations support the statement in the new investment application that there are major health disparities in rates of unintended pregnancies and that the physical, psychological, and economic ramifications of carrying an unintended pregnancy to term because of barriers to abortion care are enormous. We support access to abortion as a component of comprehensive health care and believe any potential barrier to access should be removed. As such, we support the Administration's proposal to leverage state and federal funds to help improve access to medically necessary abortions, regardless of whether the patient receiving care is a Vermont resident or if their income exceeds Medicaid limits.
