Home Health, High Technology Nursing, & Pediatric Palliative Care Rate Changes

Policy Summary:

Vermont Medicaid is updating rates for the following:

- Medicaid State Plan Home Health services
- Pediatric Palliative Care Program services
- High Technology Program, nursing services provided by a home health agency, and
- High Technology Program, nursing services provided by independently enrolled nurses.

The home health agency high technology nursing rates will also apply to the High Technology Nursing Program Payment Model described in <u>Final GCR 21-028</u> and <u>Final GCR 22-073</u>.

Rate charts are in the Additional Information section below. The final rate changes are approved as a result of legislative appropriations.

Effective Date:

February 15, 2023

Authority/Legal Basis:

This change is being done through Global Commitment to Health waiver authority, where DVHA may establish rates with providers on an individual or class basis without regard to the rates currently set forth in the approved State Plan.

Global Commitment to Health Waiver: Waiver authority #5 [Section 1902(a)(13), 1902(a)(30)]; Special Term and Condition #6.8.

Fiscal Impact:

The estimated gross annualized budget impact for home health agency services is \$1,109,880. The estimated gross annualized budget impact for independently enrolled nurses is \$165,312.
