GCR 23-027 PROPOSED

COVID-19 Vaccines, Testing, and Treatment

Policy Summary:

Vermont Medicaid is submitting a State Plan Amendment (SPA) to the Centers for Medicare and Medicaid Services assuring that COVID-19 vaccine and administration, testing, and treatment benefits are covered without cost sharing.

Medicaid members will not incur copays for services, drugs, testing, and vaccines, related to the treatment and prevention of COVID-19 during the American Rescue Plan Act coverage period. This remains in place until the end last day of the first calendar quarter that begins one year after the last day of the federal COVID-19 public health emergency declaration. This is anticipated to be September 30, 2024. Vermont Medicaid will maintain coverage of COVID-19 services as medically necessary following the end of the mandatory coverage period.

Vermont Medicaid complies with all of the Health and Human Services COVID-19 Public Readiness and Emergency Preparedness Act provisions. This includes authorization for pharmacists and other practitioners to administer COVID-19 vaccines during the PREP Act authorization period.

Payment for COVID-19 vaccine administration is set at \$40 to align with Medicare rates.

This will be submitted to CMS as SPA # 23-0013 and applies to the Alternative Benefit Plan (ABP) for the New Adult Group. The ABP replicates the full Medicaid State Plan and includes the 10 essential health benefits required under the Affordable Care Act, as well as the full range of Early and Periodic Screening, Diagnostic and Treatment (EPSDT) services for individuals under the age of 21.

These changes are retroactive to March 11, 2021

American Rescue Plan Act of 2021
