## **Reimbursement for Federally Qualified Health Centers and Rural Health Clinics**

### **Policy Summary:**

The Vermont Medicaid program increased the Federally Qualified Health Center (FQHC) and Rural Health Clinic (RHC) Prospective Payment System (PPS) rates by 10 percent for dates of service on or after July 1, 2023. This increased funding is part of the State Fiscal Year 2024 budget appropriation from the Vermont State Legislature.

The rate sheet has been adjusted to correct a typo in the rate listed for the Community Health Centers of the Rutland Region. It has been corrected to reflect the proper rate, which is the rate the facility received in their rate notification letter dated July 6, 2023.
