### Introduction

► The Agency of Human Services (AHS) is planning to launch several grant opportunities for HCBS providers and community-based organizations that primarily serve Medicaid members with HCBS needs.

► Will award up to \$20M in grants funded through <u>Section 9817</u> of the American Rescue Plan Act.

Four proposed grant funding opportunities for feedback.

### What are HCBS Services?

- ► HCBS include medical and non-medical services that are provided in a home or community-based setting rather than an institutional setting.
- A variety of populations receive HCBS to assist with daily living.
- Examples of HCBS include home health care, personal care services (dressing, bathing etc.), case management, and substance use disorder treatment.

## How are community-based organizations defined under this funding opportunity?

- Organizations will need to demonstrate through their application that they primarily serve Medicaid members with HCBS needs.
- **Examples** of community-based organizations may include:
  - Advocacy organizations
  - Community Action Agencies
  - Homeless Shelter and Service Providers
  - Peer-run Organizations
  - Recovery Organizations
  - Senior Centers
- Where appropriate, partnerships between HCBS providers and communitybased organizations are also encouraged.

## Track 1: Infrastructure Improvements

- Infrastructure improvement grants offer one-time, long-term investments that can be used to support improvements to physical infrastructure and facilities. This grant track is intended to expand services and capabilities, enabling providers to meet the evolving needs of their communities.
- Examples of projects that may be funded:
  - Improve facilities' accessibility and compliance with the ADA
  - Expand capacity in community settings
  - Ensure compliance with HCBS settings requirements
  - ► HVAC system upgrades
  - Increase building energy efficiency such as replacing leaky windows

## Track 1: Target Audience

- ► HCBS providers that are fully compliant with the HCBS settings criteria or will become compliant due to improvements funded through this grant opportunity
- Other HCBS providers offering Medicaid State Plan outpatient services

## Track 2: Workforce Development

- ► This track aims to enhance professional development among HCBS providers and promote employee retention and growth, while also supporting initiatives to enhance equipment and technology that improves staff productivity and reduces administrative burden.
- Funding towards projects that:
  - Expand training opportunities
  - Promote employee attainment of certifications and other career advancement opportunities
  - Enable mentorship opportunities
  - ▶ Enhance job satisfaction and morale for HCBS direct care workers
  - Equipment and secure technology purchases that reduce administrative burden and improve staff productivity and experience,
    - ▶ I.e., tablets that allow direct care staff to enter data at the point of care or equipment to support remote work.
  - Ineligible expenses include:
    - ▶ Employee retention and recruitment bonuses
    - Purchase of Care Coordination Tools and Electronic Health Records

## Track 2: Target Audience

#### HCBS Providers

- ► Can include partnerships between HCBS providers with a lead provider or a membership organization with letters of commitment from HCBS providers
- Educational institutions
  - i.e. Colleges or universities, seeking to enhance their healthcare curriculum or develop skills and training programs
- School districts or schools that serve children with HCBS needs or employ HCBS direct care workers
- Workforce development organizations that focus on HCBS and healthcare
- Community-based organizations that primarily serve Medicaid members who have HCBS needs

### Track 3: Care Model Innovation Pilots

#### **Examples** of projects that may be funded:



### Health Related Social Needs (HRSN)

Piloting delivery of pre-tenancy supports, tenancy sustaining services, and community transition services.

Provision of medically tailored meals.

Costs associated with coordinating and delivering HRSN services, including personnel, training, and outreach.



#### **Health Equity**

Culturally responsive outreach and communication efforts, including translation services and community engagement initiatives to increase access to information about HCBS.

Resources for community advocacy projects/groups aimed at addressing health inequities among individuals who use HCBS services.



#### **Health and Wellness**

Implementation of evidence-based health and wellness interventions, such as a falls prevention program.

Costs associated with training and capacity building efforts to support program staff and individuals with HCBS needs.



#### Care Integration

Co-locating staff such as peers or community health workers in primary care or other health care settings.

Innovative approaches to shared care planning, providing follow-up services after hospitalization or emergency department visits, and transitions between care settings.

Utilization and effectiveness of telehealth services for remote or underserved populations.

Ineligible expenses may include construction, room and board, utility subsidies, and other exclusions.

## Track 3: Target Audience

- ► Healthcare organizations, systems, networks or providers, including HCBS providers, hospitals that partner with an HCBS provider, clinics, community health centers who serve Medicaid members who utilize HCBS
- Community-based organizations that primarily serve Medicaid members who have HCBS needs

## Track 4: Organizational Performance Improvement and Compliance Grants

- Funding to support the development or enhancement of internal policies and systems to improve access to and quality of Medicaid HCBS and/or ensure compliance with state and federal requirements.
- Funds will support project execution, and the necessary administrative staff, contractors, and materials.
- Examples of proposals may include:
  - Developing business models and business practices that reduce conflict of interest in performing assessments and care plans
  - Programming and technical assistance to integrate Admission, Discharge and Transfer notification services with other systems
  - Changing business practices to support data reporting in alternative and valuebased payment model arrangements
  - Designing and implementing improved processes for data collection, timeliness and accuracy

## Track 4: Target Audiences

- ► HCBS providers
  - ► Can include partnerships between HCBS providers with a lead provider or a membership organization with letters of commitment from HCBS providers
