Increase to the Personal Needs Allowance and Aid for the Aged, Blind, and Disabled – Medicaid State Plan Amendments

Policy Summary:

The Vermont Medicaid program proposes to amend the Medicaid State Plan to reflect an increase in the Personal Needs Allowance (PNA) and an increase in the Aid to the Aged, Blind, and Disabled (AABD) state supplementary payments. The increase to the PNA will be applied to all Medicaid enrollees receiving long-term care, regardless of whether they receive supplemental security income (SSI). The Vermont State Legislature appropriated funding for these increases.

Personal Needs Allowance:

The increase to the PNA for institutionalized individuals/couples increases the amount that can be deducted for purposes of calculating post-eligibility treatment of income. This change will be submitted to the Centers for Medicare and Medicaid Services as State Plan Amendment #24-0006.

Optional State Supplement Beneficiaries Eligibility Group:

The income standards for the Optional State Supplement Beneficiaries Medicaid eligibility group vary by payment classification and are a product of the SSI federal benefit rate added to the maximum AABD payment level for each classification. The new standards can be found in the table under "Additional Information" below. This change will be submitted to the Centers for Medicare and Medicaid Services as State Plan Amendment #24-0004.

Population Affected:

Medicaid beneficiaries receiving long-term care. Medicaid beneficiaries receiving AABD payments.



Fiscal Impact:

The estimated gross annualized budget impact is \$1,500,000.
