GCR 24-072 PROPOSED

Hospice Services Rate Changes

Policy Summary:

The Vermont Medicaid program is updating rates for hospice services. This change is a result of the State Fiscal Year 2025 Appropriations Act. Vermont Medicaid follows the Medicare rate methodology for hospice services and had previously set the 2024 rates for hospice services at 100% of the Medicare rates. DVHA is adding a 3% rate increase as of July 01, 2024. Further details on the rate changes can be found under "Additional Information" below.

Authority/Legal Basis:

State Fiscal Year 2025 Appropriations Act 113 (H.883)

Medicaid State Plan

This change is being done through Global Commitment to Health waiver authority, where DVHA may establish rates with providers on an individual or class basis without regard to the rates currently set forth in the approved State Plan.

Global Commitment to Health Waiver: Waiver authority #5 [Section 1902(a)(13), 1902(a)(30)]; Special Term and Condition #6.8.

The estimated gross annualized budget impact is \$36,000.
