<u>Home Health, High Technology Nursing, & Pediatric Palliative Care</u> <u>Rate Changes</u>

Policy Summary:

Vermont Medicaid is updating the rates for Home Health, High Technology Nursing, and Pediatric Palliative Care Services to the base rates of 100% of the Medicare Low Utilization Payment Adjustment (LUPA) rate for Vermont. The previous rate was 100% of LUPA plus an additional increase of 3% due to Legislative appropriations in the State Fiscal Year 2025 Appropriations Act as noticed in <u>GCR 24-070</u>.

Rate charts are in the Additional Information section below.

The Global Commitment Amended State Plan pages are also being amended to update the date that rates were set for licensed dental hygienist services, licensed dental therapist services, and private duty nursing services, and to reflect the payment methodology for licensed lay midwife services. These are technical corrections that do not represent a change to the reimbursement methodology.

Effective Date: January 01, 2025

Authority/Legal Basis: Medicaid State Plan

This change is being done through Global Commitment to Health waiver authority, where DVHA may establish rates with providers on an individual or class basis without regard to the rates currently set forth in the approved State Plan.

<u>Global Commitment to Health Waiver</u>: Waiver authority #5 [Section 1902(a)(13), 1902(a)(30)]; Special Term and Condition #6.8.

Population Affected: All Medicaid

Fiscal Impact: The estimated gross annualized budget impact is \$845.00.
