GCR 19-032 PROPOSED

Medicaid Transportation Reimbursement Rates

Policy Summary:

The Department of Vermont Health Access (DVHA) administers emergency and non-emergency medical transportation (NEMT) for Medicaid beneficiaries. Emergency transportation is provided via ambulance. NEMT rides are provided through the Vermont Public Transportation Association; beneficiaries can also receive non-emergent transportation via ambulance when other forms of transportation would be medically contra-indicated.

DVHA is proposing to increase the rates for ambulance services to better align with Medicare reimbursement rates. This rate increase is part of the State Fiscal Year (SFY) 2020 budget appropriation from the Vermont State Legislature. Further details on the rate changes can be found under "Additional Information" below. NEMT is paid at a per member, per week rate of \$34 per unique member. The NEMT rate is not changing at this time and does not include ambulance services.

Effective Date:

July 1, 2019

Authority/Legal Basis:

This change is being done through Global Commitment to Health waiver authority, where DVHA may establish rates with providers on an individual or class basis without regard to the rates currently set forth in the approved State Plan.

Global Commitment to Health Waiver: Waiver authority #5 [Section 1902(a)(13), 1902(a)(30)]; Special Term and Condition #29.
